

## Official USA Status of On-Line Vital Records by USA Counties and States

I just went on-line to order the death certificate for my sister. Apparently, the City of Los Angeles is still processing on-line orders even though their offices are closed. To help of you, here's the official status of USA county and state agencies for your convenience. Suggest you take advantage of those counties and states that are still processing vital record requests. **Note: most agencies are still processing on-line orders.**

This morning (Sunday) I wrote to the City of Beverly Hills, California in quest of obtaining a death certificate for my sister and the City Manager of Beverly Hills promptly responded to me with this insightful URL below this very same Sunday afternoon.
